The University hosts 5 research institutes, 13 research laboratories, Institute of post diploma education for managers and specialists in veterinary medicine, Institute of European Integration, Education and Research Institute of Economics and Business, 8 colleges, research establishments and University training farm. The total number of students is 9538. The teaching staff consists of 12 academicians, 54 doctors of sciences, professors, 257 candidates of sciences (PhD). The University is member of several international education and research organizations e.g. EAEVE, ERDN, PEEX, VUA and participated in a number of international education and research projects of FR7, Tempus, Erasmus+ and other programs.</p>
